February 23, 2009

Mayor DiTullio called the Regular City Council Meeting to order at 7:00 p.m. Councilmembers present: Karen Adams, Karen Berry, Dean Gokey, Tracy Langworthy, Lena Rotola, Wanda Sang, Mike Stites, and Terry Womble. Also present: City Clerk, Michael Snow; City Manager, Randy Young; City Attorney, Gerald Dahl; Director of Community Development, Kenneth Johnstone; Director of Public Works, Tim Paranto; Planner, Jeff Hirt; staff; and interested citizens.

APPROVAL OF MINUTES OF February 9, 2009

Motion by Mrs. Sang for approval of the Minutes of February 9, 2009; seconded by Mr. Stites; carried 8-0.

PROCLAMATIONS AND CEREMONIES

Karen Thaler, Mrs. Wheat Ridge, read the Proclamation for National Multiple Sclerosis Awareness Week – March 2–8, 2009.

CITIZENS' RIGHT TO SPEAK

Patricia Jones of Golden spoke on the citizen effort to save Lutheran Medical Center from takeover by a religious organization, the Sisters of Charity of Leavenworth Health System. Mrs. Jones contends that this purchase will jeopardize a fundamental community service in Wheat Ridge, threatening comprehensive health care with ethical and religious doctrines and reduced health care choices. What's more, if the hospital is purchased, the new owners will take 100% of the hospital's profits out of Wheat Ridge to its headquarters in Kansas. Mrs. Jones urged citizens to attend one of several public awareness meetings scheduled in the area and to join the effort to stop the purchase.
