TITLE: AN ORDINANCE AMENDING THE WHEAT RIDGE CODE OF LAWS TO GIVE THE DIRECTOR OF PARKS AND RECREATION THE AUTHORITY TO DETERMINE WHEN, WHERE AND UNDER WHAT CONDITIONS SLEDDING WILL BE ALLOWED ON CITY PROPERTY

WHEREAS, the City Council is authorized to adopt ordinances for management of City property and protection of public health and safety; and

WHEREAS, in the exercise of this authority; the Council has previously adopted Section 17.54 of the Code of Laws, concerning winter sports on City-owned property, which among other things, prohibits sledding on City property; and

WHEREAS, the City Council wishes to amend Section 17-54 to authorize the director of the parks and recreation to permit sledding at specific locations and under specific conditions.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHEAT RIDGE, COLORADO:

Section 1. Section 17.54(c) of the Wheat Ridge Code of Laws is amended to read:

(c)Sledding is prohibited within any park, open space or recreational facility of the city, PROVIDED, HOWEVER, THE DIRECTOR OF PARKS AND RECREATION MAY, BY ADMINISTRATIVE ORDER, PERMIT SLEDDING AT SPECIFIC LOCATIONS AND UNDER SPECIFIC CONDITIONS.

Section 2. Severability, Conflicting Ordinances Repealed. If any section, subsection or clause of this Ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections and clauses shall not be affected thereby. All other ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

<u>Section 3.</u> <u>Effective Date.</u> This Ordinance shall take effect fifteen (15) days after final publication, as provided by Section 5.11 of the Charter.
