- 3) **\$10,000 LICENSE & PERMIT BOND.** Work done under each permit issued with this license bond requires a **two year warranty period.**
- 4) **Corporation / LLC EIN** (Employer Identification #) **or Lawful Presence Affidavit** (notarized with copy of authorized identification.
